 - iii. RATIFY Rock Enclosures (Bubblers) Quality Lakes; \$2,200 Scott Kody made a motion "to ratify Quality Lakes, Inc for rock enclosures (bubblers), includes shipping, tax and install for \$2,200.00." Chris Goodman seconded the motion. The motion passed without opposition.

- v. RATIFY Spring Meadow Clean-Up Ramos Landscaping; \$1,800 Scott Kody made a motion "to ratify Ramos Landscaping for pruning and clean up of debris at Spring Meadow for \$1,800.00." Chris Goodman seconded the motion. The motion passed without opposition.
- vi. RATIFY Electronic Inspection & Repairs Live Oak Electrical; \$7,445 Scott Kody made a motion "to ratify Live Oak Electrical Services for electrical inspection and repairs for \$7,445.00." Chris Goodman seconded the motion. The motion passed without opposition.

- viii. RATIFY Pond #7 Suction Line Replacement Pinckney Well; \$3,950 Scott Kody made a motion "to ratify Pinckney Well Drilling and Water Industry for \$3,950.00 to include labor, equipment and materials for installation." Chris Goodman seconded the motion. The motion passed without opposition.
- ix. RATIFY Elliptical Replacement Island Fitness; \$4,588.18 Rick Wells made a motion "to ratify Island Fitness Equipment Services for New Octane Pro 310 Classic Elliptical replacement, includes freight, installation, warranty and removal of the out of order elliptical." Daniel Glover seconded the motion. The motion passed without opposition.
- x. RATIFY Deterrent Cameras Custom Security; \$1,500 Rick Wells made a motion "to ratify Custom Security for CCT System; 2 replacement digital deterrent camera w/strobe and speaker." Daniel Glover seconded the motion. The motion passed without opposition.
